Payment Regulations

PAYMENT SCHEMES

TERMS OF PAYMENT:

I. The properties are to be sold under the following standard payment scheme:

- 1000 Euros reservation fee - in the moment of reservation;
- 30 % of the sale price - upon signing of a preliminary sale agreement, within one calendar month from the payment of the reservation fee.
- 40 % of the sale price - within 3 months from the payment of the deposit. (A)
- 30 % - the rest of the price - within three months from the payment of the second installment (C) , at the transfer of ownership;

II. The Developer has a very flexible payment policy; there is an option that an individual payment plan is made for each particular client:

- 1000 Euros reservation fee - in the moment of reservation;
- 30 % of the sale price - upon signing of a preliminary sale agreement, within one calendar month from the payment of the reservation fee.
- the remaining 70% can be paid in as many installments as the buyer prefers, within 1 calendar year from the deposit (A);

The buyer can set the number of the installments, the dates and the amounts himself. However in this case we request that the last installment is no bigger than 15%; at the transfer of ownership.
